**Waiver in Exemption Fee for the Holders of Academic and

4-Years BBA (Hons)/MBA	5 Courses up to Semester 3
2-Years MBA	3 Courses up to Semester 3

If a student passes Gateway Assessment Examination, the following exemptions would be applicable:

Qualification/Degree Program	Available Exemptions
B.Com.	6 Courses up to Semester 2
M. Com.	9 Courses up to Semester 3
4-Years BBA (Hons)/MBA	9 Courses up to Semester 3
2-Years MBA	9 Courses up to Semester 3

Meritorious Scholarship

A student may avail scholarships/financial assistance as follows:

Sr.	Description of Achievement	Assistance
1.	First, second or third position holders	100% of Tuition Fee
2.	Secured 85% to 90% marks	75% of Tuition Fee
3.	Secured 75% to 84% marks	50% of Tuition Fee


Waiver in Exemption Fee
